### **Electro Optic Systems Holdings Limited – request for trading halt**

Pursuant to ASX Listing Rule 17.1, Electro Optic Systems Holdings Limited ABN 95 092 708 364 (ASX: EOS) (**EOS**) requests an immediate trading halt be granted by ASX in respect of its ordinary shares.

EOS requests the trading halt pending an announcement by EOS in relation to entry into a material contract for the sale of Remote Weapon Systems and a material contract to establish a joint venture, the disclosure of both of which is presently being finalised (**Purpose**).

In accordance with ASX Listing Rule 17.1, EOS provides the following information:

- (a) **Reason for trading halt:** the trading halt is requested to allow the Company to manage its continuous disclosure obligations in relation to the Purpose. The trading halt is requested to ensure that EOS' shares are not trading on a misinformed basis.
- (b) **Duration of the trading halt:** EOS requests that the trading halt remain in place until the earlier of:
  - (i) EOS making an announcement relating to the Purpose; and
  - (ii) the commencement of trading on Monday, 22 June 2026.
- (c) **No reason:** EOS is not aware of any reason why the trading halt should not be granted by ASX.
- (d) **Further information:** EOS is not aware of any further information which needs to be disclosed to the market at the time of seeking the trading halt.

This request has been authorised for release to ASX by the Chair of the Audit and Risk Committee of the Company.
